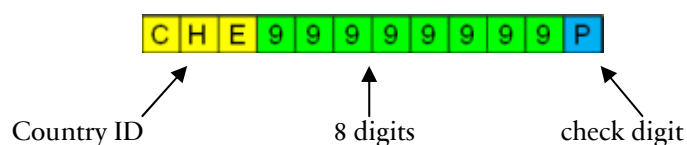


New features from 25th February 2011

Integration of the Enterprise Identification Number (the *Unternehmens-Identifikationsnummer*, UID)

From 2011 onwards, every business operating in Switzerland will be assigned a single Enterprise Identification Number (UID number). The UID numbers of more than 500,000 companies registered in the commercial register are now added and available on Teledata. The UID will replace the existing commercial register numbers and value added tax (Mehrwertsteuer) numbers in stages, and is intended to be used in all the Federal and Cantonal administration systems by 2015 at the latest.

The UID is generated as follows:



Advantages:

- Unique identification of the business
- Easier exchange of information with the public administration system
- Reduced administrative costs
